Dr. Theo and Friedl Schöller Research Center for Business and Society: Announcement of Fellowships

Dear Sir or Madam,

Based on the research focus of the School of Business, Economics and Society “Creating Cohesion – Designing Change – Realizing Innovation”, the Dr. Theo and Friedl Schöller Research Center supports top-level research in Nuremberg within an international context. Namely by creating and cultivating an international research network of outstanding scholars and establishing vibrant research collaborations with local roots and global outreach.

The Schöller Research Center grants research fellowships for outstanding scholars on an annual basis in the following two categories:

- **Schöller Senior Fellow**
for internationally renowned scholars
- **Schöller Senior Fellow**
for promising early-career scholars
(including assistant professors, postdocs, and outstanding PhD students)

The faculty members of the School of Business, Economics and Society are invited to contact and/or nominate promising candidates.

Selection Criteria

The selection of the Schöller Fellows is based on the following criteria:

- willingness to engage in on-site cooperation and dialogue in Nuremberg and already existing or intended collaboration with professors of the School of Business, Economics and Society,
- scientific excellence as demonstrated by top-tier publications, and
- theoretical rigor and practical relevance of the outlined research project.

Each Fellow shall be affiliated with at least one of the School’s Institutes or Chairs and contribute to its reputation with her/his research.



Rights and Obligations of the Fellows

The Dr. Theo and Friedl Schöller Research Center provides funds of up to 50.000 € per Schöller Senior Fellow and up to 20.000 € per Schöller Fellow for the realization of a proposed research project.

Schöller Fellows are required to contribute to the research activities of the School of Business, Economics and Society by sharing their experiences and competencies. In addition, the Fellows are expected to

- participate in the annual Award Ceremony of the Schöller Research Center,
- acknowledge the support provided by the Research Center in all publications related to their Fellowship, and
- report on the progress and results of their research project on a regular basis.

Application for a Schöller Fellowship

The application form can be downloaded from www.schoeller-research.org/application. Applications must be submitted by both mail (original document) and e-mail (electronic copy) to the Directors' Office of the Dr. Theo and Friedl Schöller Research Center within the stated application period. **The application deadline is December 31 of each year.**

The professors and institutions of the School of Business, Economics and Society are welcome to nominate appropriate candidates. In this case, a [recommendation letter](#) should be enclosed to the application form.
